BAC RESOLUTION DECLARING NANOSCIENCE INC. AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 27, 2024 the Request for Quotation for the Purchase of Effervescent Water Purification Tab with the Approved Budget for the Contract (ABC) of One Hundred Twenty Thousand Pesos (\$\mathbb{P}\$120,000.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 5 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

WHEREAS, upon careful examination, validation, and verification by the Technical Working Group (TWG) of all the eligibility, technical, and financial requirements submitted by the three (3) suppliers, the quotation of NANOSCIENCE INC. was found to be the Lowest Calculated Responsive Quotation (LCRQ).

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare NANOSCIENCE INC. as the winning supplier for the Purchase of Effervescent Water Purification Tab for the use of the Provincial Health Office under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.


