



**RESOLUTION NO. 084-AG s. 2024**

**BAC RESOLUTION DECLARING AGB REFRIGERATION CENTER AND TOYOTA LA UNION AS THE LOWEST CALCULATED RESPONSIVE QUOTATIONS (LCRQs) AND RECOMMENDING AWARD OF CONTRACT**

**WHEREAS**, the Provincial Government of La Union (PGLU) advertised on August 15, 2024 the Request for Quotation for the **Repair and Maintenance of Rescue Vehicle** with the **Approved Budget for the Contract (ABC)** of **One Hundred Eight Thousand One Hundred Seventy-Five Pesos (₱108,175.00)** in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 7 days;
