



**RESOLUTION NO. 326-AG s. 2024**

**BAC RESOLUTION DECLARING JCG INDUSTRIAL TECHNOLOGIES AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT**

**WHEREAS**, the Provincial Government of La Union (PGLU) advertised on December 18, 2024 the Request for Quotation for the **Purchase of Teflon Filter** with the **Approved Budget for the Contract (ABC)** of **Fifty-Seven Thousand Five Hundred Pesos (₱57,500.00)** in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 5 days;

**WHEREAS**, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
