BAC RESOLUTION DECLARING JCG INDUSTRIAL TECHNOLOGIES AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 18, 2024 the Request for Quotation for the Purchase of Teflon Filter with the Approved Budget for the Contract (ABC) of Fifty-Seven Thousand Five Hundred Pesos (₱57,500.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 5 days;
