BAC RESOLUTION DECLARING DEUS ENTERPRISES CO. AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on October 430, 2024 the Request for Quotation for the Purchase of Torch Light and Raincoat with the Approved Budget for the Contract (ABC) of Sixty-Eight Thousand Nine Hundred Seventy-Four Pesos (\$\mathbb{P}68,974.00)\$ in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 7 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


