



RESOLUTION NO. 081-AG s. 2024

BAC RESOLUTION DECLARING TOYOTA LA UNION AND CARR BRAKE AUTO SUPPLY AS THE LOWEST CALCULATED RESPONSIVE QUOTATIONS (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on August 7, 2024 the Request for Quotation for the **Repair and Maintenance of Transportation Equipment and Service Vehicle** with the **Approved Budget for the Contract (ABC)** of **Two Hundred Fourteen Thousand One Hundred Four Pesos and Two Centavos (P214,104.02)** in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 7 days;

WHEREAS, in response to the said advertisement, four (4) suppliers submitted their quotations as follows:
