BAC RESOLUTION DECLARING LEVATECH TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 11, 2024 the Request for Quotation for the Purchase of ICT Equipment with the Approved Budget for the Contract (ABC) of Seven Hundred Sixty Thousand Pesos (\$\mathbb{P}760,000.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 5 days;
