BAC RESOLUTION DECLARING BROWNSTONE ASIA-TECH, INC. AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 27, 2024 the Request for Quotation for the Purchase of Chemical Products with the Approved Budget for the Contract (ABC) of One Hundred Six Thousand Pesos (₱106,000.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 5 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

WHEREAS, upon careful examination, validation, and verification by the Technical Working Group (TWG) of all the eligibility, technical, and financial requirements submitted by the three (3) suppliers, the quotation of **BROWNSTONE ASIA-TECH**, / **INC.** was found to be the Lowest Calculated Responsive Quotation (LCRQ).

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare **BROWNSTONE ASIA-TECH, INC.** as the winning supplier for the **Purchase of Chemical Products** for the use of the **Provincial Health Office** under the Provincial Government of La Union; and
