BAC RESOLUTION DECLARING MEDSPECS SOLUTIONS INC. AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 13, 2024 the Request for Quotation for the Purchase of Disinfectant Supplies with the Approved Budget for the Contract (ABC) of One Hundred Five Thousand Pesos (₱105,000.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
