WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 12, 2024 the Request for Quotation for the Supply and Delivery of Drugs and Medicines with the Approved Budget for the Contract (ABC) of Six Hundred Six Thousand Six Hundred Pesos (\$\mathbb{P}606,600.00\$) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 4 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
