BAC RESOLUTION DECLARING A-RAMP TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 29, 2024 the Request for Quotation for the Supply and Delivery of Electrical Supplies with the Approved Budget for the Contract (ABC) of Nine Hundred Ninety-Six Thousand Pesos (\$\mathbb{P}996,000.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare A-RAMP TRADING as the winning supplier for the Supply and Delivery of Electrical Supplies for the use of the Office of the Provincial Governor under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.
