BAC RESOLUTION DECLARING BAMCOR FIRE EXTINGUISHER AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 19, 2024 the Request for Quotation for the Purchase of Fire Extinguisher with the Approved Budget for the Contract (ABC) of Two Hundred Two Thousand Two Hundred Pesos (₱202,200.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 4 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
