BAC RESOLUTION DECLARING V-JECS TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 20, 2024 the Request for Quotation for the Purchase of Fish Farming Tub Pond with the Approved Budget for the Contract (ABC) of One Hundred Forty-Nine Thousand Nine Hundred Ninety-Seven Pesos (₱149,997.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 5 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
