BAC RESOLUTION DECLARING CARR BRAKE AUTO SUPPLY AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 18, 2024 the Request for Quotation for the **Repair and Maintenance of Generator Set** with the **Approved Budget for the Contract (ABC)** of **Sixty-Three Thousand Eight Hundred Ninety-Two Pesos (P63,892.00)** in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 5 days;
