BAC RESOLUTION DECLARING BALAI NORTE HOTELS AND RESORTS CORPORATION AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on September 20, 2024 the Request for Quotation for the Provision of Hotel Accommodation with the Approved Budget for the Contract (ABC) of Fifty-Six Thousand Pesos (₱56,000.00) in the PGLU Website, PhilGEPS Website, and Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare BALAI NORTE HOTELS AND RESORTS CORP. as the winning supplier for the Provision of Hotel Accommodation for the use of the La Union Provincial Tourism Office under the Provincial Government of La Union; and
