BAC RESOLUTION DECLARING METROVISION CUSTOMIZED PRINTING & GENERAL MERCHANDISE AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 12, 2024 the Request for Quotation for the Purchase of IEC Materials with the Approved Budget for the Contract (ABC) of One Hundred Nineteen Thousand Pesos (\$119,000.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 4 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
