BAC RESOLUTION DECLARING METROVISION CUSTOMIZED PRINTING AND GENERAL MERCHANDISE AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on October 16, 2024 the Request for Quotation for the Purchase of Advocacy Jacket with the Approved Budget for the Contract (ABC) of Eighty Thousand Pesos (\$\mathbb{P}80,000.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 5 days;
