BAC RESOLUTION DECLARING ELLEX DRUG AND GENERAL MERCHANDISE AS THE LOWEST CALCULATED RESPONSIVE QUOTATIONS (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 12, 2024 the Request for Quotation for the **Purchase of Laboratory Supplies and Equipment** with the **Approved Budget for the Contract (ABC)** of **Two Hundred Two Thousand Eight Hundred Fifty Pesos (P202,850.00)** in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 4 days;
