WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 4, 2024 the Request for Quotation for the Purchase of Medical and Laboratory Supplies with the Approved Budget for the Contract (ABC) of Nine Hundred Ninety-Nine Thousand One Hundred Twenty-Seven Pesos and Fifty Centavos (\$\mathbb{P}999,127.50)\$ in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 5 days;

**WHEREAS**, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
