BAC RESOLUTION DECLARING TIMMATE ENTERPRISES AND LEVATECH TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATIONS (LCRQs) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 7, 2024 the Request for Quotation for the Purchase of Photocopier Supplies with the Approved Budget for the Contract (ABC) of Two Hundred Thirty-Seven Thousand Pesos (\$\mathbb{P}237,000.00)\$ in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 7 days;
