BAC RESOLUTION DECLARING GIOSETECH GENERAL MERCHANDISE AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 11, 2024 the Request for Quotation for the Purchase of Photocopier Supplies with the Approved Budget for the Contract (ABC) of Three Hundred Sixty-Five Thousand Seven Hundred Six Pesos (\$\mathbb{P}365,706.00)\) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 5 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

- A. To declare GIOSETECH GENERAL MERCHANDISE as the winning supplier for the Purchase of Photocopier Supplies for the use of the Office of the Provincial Administrator under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.
