BAC RESOLUTION DECLARING FILHOLLAND CORPORATION AND CARR BRAKE AUTO SUPPLY AS THE LOWEST CALCULATED RESPONSIVE QUOTATIONS (LCRQs) AND RECOMMENDING AWARD OF CONTRACT
