BAC RESOLUTION DECLARING ANGLOWEALTH ENTERPRISES AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 6, 2024 the Request for Quotation for the **Purchase of Heavy Duty Tents** with the Approved Budget for the Contract (ABC) of Nine Hundred Seventy-Seven Thousand Pesos (\$\mathbb{P}977,000.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


