BAC RESOLUTION DECLARING TOP SPEED AUTO PARTS AND CARR BRAKE AUTO SUPPLY AS THE LOWEST CALCULATED RESPONSIVE QUOTATIONS (LCRQs) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on August 22, 2024 the Request for Quotation for the Repair and Maintenance of Heavy Equipment and Trucks with the Approved Budget for the Contract (ABC) of Seven Hundred Fifty-Seven Thousand Two Hundred Eighty Pesos (P757,280.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 7 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
