BAC RESOLUTION DECLARING GIOSETECH GENERAL MERCHANDISE AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on August 7, 2024 the Request for Quotation for the **Purchase of Office Equipment** with the **Approved Budget for the Contract (ABC)** of **Four Hundred Three Thousand Nine Hundred Ninety-Three Pesos (P403,993.00)** in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 7 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
