RESOLUTION RECOMMENDING THE APPROVAL AND ADOPTION OF DIRECT CONTRACTING OR SINGLE SOURCE PROCUREMENT THROUGH AN EXCLUSIVE DEALER OR MANUFACTURER AS AN ALTERNATIVE METHOD OF PROCUREMENT FOR THE PURCHASE OF NEWBORN SCREENING KIT AND HEARING REGISTRY SEALS FOR THE USE OF ROSARIO DISRICT HOSPITAL.

WHEREAS, presented before this Body is the need for the Purchase of Newborn Screening Kit and Hearing Registry Seals for the use of the Rosario District Hospital amounting Seven Hundred Twenty Thousand Pesos (P720,000.00);

WHEREAS, Section 50(b) of Rule XVI of the Revised Implementing Rules and Regulations (IRR) of RA 9184 provides for Direct Contracting or Single Source Procurement as an alternative mode of procurement "when the Procurement of critical components from specific manufacturer, supplier, or distributor is a condition precedent to hold a contractor to guarantee its project performance, in accordance with the provisions his contract";

WHEREAS, under Direct Contracting or Single Source Procurement, "the supplier is simply asked to submit a price quotation or a pro-forma invoice together with the conditions of sale" and "the offer may be accepted immediately or after some negotiations";

WHEREAS, the Bids and Awards Committee (BAC), in order to promote economy and efficiency, unanimously agreed that Direct Contracting or Single Source Procurement as an alternative method of procurement provides the solution for the Purchase of Newborn Screening Kit and Hearing Registry Seals amounting to P720,000.00;

NOW THEREFORE, the BAC agreed to request for a quotation from Newborn Screening Center - Northern Luzon, the exclusive dealer and accredited/eligible supplier for the Purchase of Newborn Screening Kit and Hearing Registry Seals;

WHEREFORE, on motion duly seconded, be it

RESOLVED, as it is hereby resolved to adopt Direct Contracting or Single Source Procurement an alternative method of procurement pursuant to Section 50(b) of the Revised IRR;

RESOLVED FURTHER, to furnish a copy of this resolution to all persons and offices concerned for their information and guidance.
