

BAC RESOLUTION DECLARING AGOO PRINTING PRESS AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF

CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 4, 2024 the Request for Quotation for the Purchase of Annual Fix Tax Stickers with the Approved Budget for the Contract (ABC) of Two Hundred Thirty-Nine Thousand Five Hundred Eighty Pesos (\$\mathbb{P}\$239,580.00) in the PGLU Website, Philageps Website, Bulletin Board at the Provincial Capitol continuously for 5 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

WHEREAS, upon careful examination, validation, and verification by the Technical Working Group (TWG) of all the eligibility, technical, and financial requirements submitted by the three (3) suppliers, the quotation of AGOO PRINTING PRESS was found to be the Lowest Calculated Responsive Quotation (LCRQ).

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare AGOO PRINTING PRESS as the winning supplier for the Purchase of Annual Fix Tax Stickers for the use of the Office of the Provincial Treasurer under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.
