MULTI-PURPOSE COOPERATIVE AS THE LOWEST CALCULATED RESPONSIVE
QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 6, 2024 the Request for Quotation for the Purchase of Tokens with the Approved Budget for the Contract (ABC) of Eighty-Seven Thousand Five Hundred-Pesos (₱87,500.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
