WHEREAS, the Provincial Government of La Union (PGLU) advertised on October 29, 2024 the Request for Quotation for the Purchase of Wreath and Bouquet with the Approved Budget for the Contract (ABC) of Seven Hundred Two Thousand Five Hundred Pesos (₱702,500.00) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 7 days;

**WHEREAS**, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
