# BAC RESOLUTION DECLARING LA UNION PROVINCIAL GOVERNMENT EMPLOYEES MULTI-PURPOSE COOPERATIVE AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 6, 2024 the Request for Quotation for the Provision of Catering Services with the Approved Budget for the Contract (ABC) of One Hundred Thousand Eighty Pesos (P100,080.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 3 days;

**WHEREAS**, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.


