BAC RESOLUTION DECLARING AGB REFRIGERATION CENTER, CARR BRAKE AUTO SUPPLY AND TOYOTA LA UNION AS THE LOWEST CALCULATED RESPONSIVE QUOTATIONS (LCRQs) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 12, 2024 the Request for Quotation for the Repair and Maintenance of Service Vehicle with the Approved Budget for the Contract (ABC) of One Hundred Fifty-Nine Thousand Six Hundred Nine Pesos and Twenty-Seven Centavos (₱159,609.27) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 4 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

WHEREAS, upon careful examination, validation, and verification by the Technical Working Group (TWG) of all the eligibility, technical, and financial requirements submitted by the three (3) suppliers, the quotations of AGB REFRIGERATION CENTER for Lot 1, CARR BRAKE AUTO SUPPLY for Lot 2 and TOYOTA LA UNION for Lot 3, were found to be the Lowest Calculated Responsive Quotations (LCRQs).

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare AGB REFRIGERATION CENTER, CARR BRAKE AUTO SUPPLY AND TOYOTA LA UNION as the winning suppliers for the Repair and Maintenance of Service Vehicle for the use of the Naguilian District Hospital and Balaoan District Hospital under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.
