# BAC RESOLUTION DECLARING ANTERIS CONSUMER GOODS TRADING AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 11, 2024 the Request for Quotation for the Purchase of ICT and Office Equipment with the Approved Budget for the Contract (ABC) of Two Hundred Twenty-Seven Thousand Nine Hundred Ninety-Seven Pesos and Seventy-Five Centavos (\$\frac{227,997.75}{100}\$) in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 5 days;

**WHEREAS**, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
