BAC RESOLUTION DECLARING THUNDERBIRD PILIPINAS HOTELS AND RESORTS, INC. AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND **RECOMMENDING AWARD OF CONTRACT**

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 19, 2024 the Request for Quotation for the Lease of Venue with Food and Room Accommodation with the Approved Budget for the Contract (ABC) of Two Hundred Sixty-Six Thousand Pesos (₱266,000.00) in the BAC Bulletin Board at the Provincial Capitol continuously for 3 days;
