**BAC RESOLUTION DECLARING THUNDERBIRD PILIPINAS HOTELS AND RESORTS, INC.  
AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND  
RECOMMENDING AWARD OF CONTRACT**

**WHEREAS**, the Provincial Government of La Union (PGLU) advertised on November 19, 2024 the Request for Quotation for the **Lease of Venue with Food and Room Accommodation** with the **Approved Budget for the Contract (ABC)** of **Two Hundred Sixty-Six Thousand Pesos (P266,000.00)** in the BAC Bulletin Board at the Provincial Capitol continuously for 3 days;

**WHEREAS**, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
