BAC RESOLUTION DECLARING SEVEN SEAGULL ENTERPRISES AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised March 18, 2025 the Request for Quotation for the Purchase of Medals with the Approved Budget for the Contract (ABC) of One Hundred Thirty-One Thousand Six Hundred Pesos (₱131,600.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare **SEVEN SEAGULL ENTERPRISES** as the winning supplier for the **Purchase of Medals** for the use of the **PG-Environment and Natural Resources Office** under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.
