BAC RESOLUTION DECLARING EMIKA NON-SPECIALIZED WHOLESALE TRADING AND TGP PHARMA INC. AS THE LOWEST CALCULATED RESPONSIVE QUOTATIONS (LCRQs) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on September 14, 2024 the Request for Quotation for the **Purchase of Drugs and Medicines** with the **Approved Budget for the Contract (ABC)** of **Six Million Four Hundred Two Thousand Four Hundred Twenty-Three Pesos and Eight Centavos (P6,402,423.08)** in the PGLU Website, Philgeps Website, Bulletin Board at the Provincial Capitol continuously for 3 days;
