BAC RESOLUTION DECLARING AGOO PRINTING PRESS AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 6, 2024 the Request for Quotation for the Printing and Binding Services with the Approved Budget for the Contract (ABC) of One Hundred Twenty-Four Thousand Nine Hundred Sixty Pesos (P124,960.00) in the PGLU Website, Philaps Website, Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare **AGOO PRINTING PRESS** as the winning supplier for the **Printing** and **Binding Services** for the use of the **Provincial Budget Office** under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.
