WHEREAS, the Provincial Government of La Union (PGLU) advertised on December 4, 2024 the Request for Quotation for the Repair and Maintenance of Service Vehicle with the Approved Budget for the Contract (ABC) of Sixty-One Thousand Eighty Pesos and Eighty-Five Centavos (P61,080.85) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 5 days;
