BAC RESOLUTION DECLARING S. RODRIGUEZ AUDIO-VIDEO MACHINE RENTAL AND SERVICES AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised on November 4, 2023 the Request for Quotation for the Rental of Audio and Visual Equipment with the Approved Budget for the Contract (ABC) of One Hundred Thirty Thousand Pesos (P130,000.00) in the PGLU Website, Philgeps Website, BAC Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
