WHEREAS, the Provincial Government of La Union advertised on February 15, 2025 the Invitation to Bid for the **Supply and Delivery of X Ray, Ultrasound and Dental Supplies- Framework Agreement (Early Procurement Activity)** with an Approved Budget for the Contract (ABC) of **Five Million Eight Hundred Eighty-Eight Thousand Two Hundred Sixty-Four Pesos Only (P5,888,264.00)** in PGLU website, the PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 7 days.
