BAC RESOLUTION DECLARING A&J PRO LIGHTS & SOUNDS RENTAL AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised June 18, 2025 the Request for Quotation for the LED Wall, Lights and Sounds Rental with the Approved Budget for the Contract (ABC) of Two Hundred Thirty Thousand Pesos (P230,000.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 5 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare A&J PRO LIGHTS & SOUNDS RENTAL as the winning supplier for the LED Wall, Lights and Sounds Rental for the use of the La Union Provincial Tourism Office under the Provincial Government of La Union;
