BAC RESOLUTION DECLARING SAVIE'S RESTAURANT AND BAR AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised June 18, 2025 the Request for Quotation for the **Provision of Catering Services** with the **Approved Budget for the Contract (ABC)** of **One Hundred Thirty-Three Thousand Three Hundred Ninety-Eight Pesos (P133,398.00)** in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 5 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:
