BAC RESOLUTION DECLARING POWERBUILT GENERAL MERCHANDISE AS THE LOWEST CALCULATED RESPONSIVE QUOTATION (LCRQ) AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, the Provincial Government of La Union (PGLU) advertised May 30, 2025 the Request for Quotation for the **Purchase of Tables and Chairs** with the **Approved Budget for the Contract (ABC)** of **Nine Hundred Twenty-Four Thousand Nine Hundred Ninety-Three Pesos (P924,993.00)** in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 3 days;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their quotations as follows:

WHEREAS, upon careful examination, validation, and verification by the Technical Working Group (TWG) of all the eligibility, technical, and financial requirements submitted by the three (3) suppliers, the quotation of **POWERBUILT GENERAL MERCHANDISE** was found to be the Lowest Calculated Responsive Quotation (LCRQ).

NOW THEREFORE, we, the Members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- A. To declare **POWERBUILT GENERAL MERCHANDISE** as the winning supplier for the **Purchase of Tables and Chairs** for the use of the **Provincial General Services Office** under the Provincial Government of La Union; and
- B. To recommend for the approval of award to the Provincial Governor of the Province of La Union based on the foregoing findings.
