WHEREAS, the Provincial Government of La Union (PGLU) advertised June 18, 2025 the Request for Quotation for the Vehicle Rental with the Approved Budget for the Contract (ABC) of Two Hundred Eighty Thousand Pesos (₱280,000.00) in the PGLU website, PhilGEPS website and BAC Bulletin Board at the Provincial Capitol continuously for 5 days;
